Anti-Ragging Committee

Maharashtra Prohibition of Ragging Act 1999, which is in effect from 15th May 1999 has the following provisions for Action against Ragging: Ragging within or outside of any educational institution is prohibited. Whosoever directly or indirectly commits, participates in, abets, or propagates ragging within or outside any educational institution shall, on conviction, be punished with imprisonment for a term up to two years and / or penalty, which may extend to ten thousand rupees. Any students convicted of an offence of ragging shall be dismissed from the educational institution and such students shall not be admitted in any other educational institution for a period of five years from the date of order of such dismissal. Ragging is prohibited as per the decision of the Supreme Court of India in Writ Petition No.(C)656/1998. AICTE has framed regulation which has been notified vide F.No.37-3/Legal/AICTE/2009 dated July 1st, 2009 (available on AICTE web portal www.aicte-india.org) Grievance Anti Ragging on curbing the menace of ragging.
